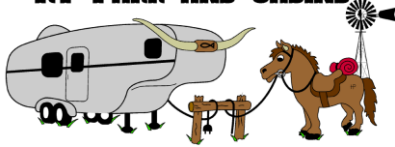

## Pet Policies

We want our guests to bring along their furry family members to enjoy our campground, but we ask that you follow these rules to keep our campground safe and clean for everyone involved.

### RV Guests-

- All dogs are required to be under the control and visual observation of their owner at all times. A 6-foot leash rule is in effect whenever the animal is outside the owner's RV. There is no exception to the leash rule unless the pet is in the dog park.
- We have a dog park located near the park entrance, where well-behaved pets may play off leash with the owner's supervision.
- A dog may not be tied up outside of an RV and left unattended while the owner leaves the park.
- Pets are not allowed inside the store/registration area, wash house, or any other indoor common areas.
- Pets may not interfere with the peace and quiet of other guests. If your dog is disturbing other guests, you will be asked to control your dog. You may also be asked to leave the park if they continue to disturb other guests after you have been warned. There will be no refunds if you are asked to leave.
- **You must pick up your pet's waste, even within your rented site.** We take pride in running a clean park. If you are found not picking up after your pet more than once, you will be asked to leave without a refund.
- All puppies and kittens under 6 mos of age need to remain in the RV until all vaccinations are received for their own health protection.
- Vaccinations for older pets must be up to date and records available for presentation upon request.
- **The Pet Owner Assumes All Responsibilities and Liabilities for their Pet.**

### Cabin Guests- In addition to the above, the following policies relate to the cabin rentals:

- We allow up to two dogs in select cabins. We need to have been informed of the pet before arrival.
- Dogs must be at least 6 mos old and housebroken.
- The pet fee for overnight rentals is \$15.00 per dog, per day. For longer rentals, it is \$100.00 per dog, per month.
- **Cats are NOT Allowed in Cabins.**
- Dogs must be kenneled if left alone in a cabin. If a dog is found to be left alone and not kenneled, a \$250 charge will be charged to the credit card on file regardless of whether any damage is found.
- A dog may not be tied up outside of a cabin and left unattended while the owner leaves the park. Crates may be rented for \$15/day from the office. Please make arrangements at least 1 day in advance.
- If your dog causes any damage or excessive work is required to return your cabin or any other area of the campground to rentable condition, you will be financially responsible for the labor and materials required and your credit card will be charged a minimum of \$250.
- No other animal species are allowed in the cabins.
